RELEASE OF LIABILITY

IN CONSIDERATION of my child's enrollment in Fresno Sunnyside Christian Academy, PSP, a California sole proprietorship, (hereinafter "FSCA") I _____ (for myself and my child(ren), agree and acknowledge as follows:

1. I understand that although FSCA is a private school with a Private School Affidavit on file with the State of California, FSCA **CANNOT GUARANTEE** our family **PROTECTION FROM INQUIRIES OR CHALLENGES** by public school or other government authorities regarding home schooling. FSCA requires that member families join Home School Legal Defense Association. I understand that FSCA **PROVIDES ONLY** the following: record keeping service, private school enrollment, teacher support services, and social interaction opportunities for enrolled students (if available).

2. I acknowledge that the FSCA has given me **NO UNDERTAKINGS, GUARANTEES WARRANTIES OR REPRESENTATIONS** whatsoever as to the **SAFETY** of any FSCA EVENT in which my child or I might participate (hereinafter "an Event"). I understand that any student who attends an Event must be accompanied by a parent/guardian or some other adult to whom the parent/guardian has entrusted the student, who assumes full responsibility for the well-being of the student.

3. I understand that it is **MY RESPONSIBILITY** to use sound judgment and practices when leading a group activity for FSCA, whether offered formally by FSCA, or informally by member families, by having another adult present (not a spouse) at all times, by not being alone with a child who is not my own, and other practices that place boundaries that prevent both child abuse and false accusation of child abuse.

4. **I VOLUNTARILY ASSUME ANY AND ALL RISKS** whatsoever associated with an Event, **INCLUDING** the risk of **PROPERTY LOSS AND SERIOUS BODILY INJURY OR DEATH.**

5. **I HEREBY RELEASE, FOREVER DISCHARGE** and covenant not to sue FSCA, its Administrator, Karon Ruiz (hereinafter "the Releasees"), from all liability and responsibility, whether in tort, contract or otherwise, for any injury, loss or damage suffered by me in connection with an Event, including **PROPERTY LOSS AND SERIOUS BODILY INJURY OR DEATH**, however caused, including the **NEGLIGENCE** of the Releasees.

6. **I HEREBY AGREE TO INDEMNIFY** and save harmless the Releasees from all claims, demands, actions, and causes of action by any other person, including my heirs, executors, insurers, successors, and assigns in consequence of any injury, loss or damage suffered by my child or I in connection with and Event. This Agreement binds my estate and will inure to the benefit of the estates of the Releasees.

7. **I EXPRESSLY AGREE THAT THIS** Waiver and Liability Exclusion **AGREEMENT IS INTENDED TO BE** as **BROAD AND INCLUSIVE** as is permitted in the jurisdiction by whose law it is interpreted. All of the terms of this agreement are severable from each other and will survive the invalidity of any other term.

8. **I HAVE READ THE ABOVE AND UNDERSTAND IT.** I am entering into this Waiver and Liability Exclusion Agreement of **MY OWN FREE WILL** and not under duress.
